

OUTREACH COORDINATOR

Job Announcement

Mental Health Colorado is a nonprofit, nonpartisan organization that works to promote mental health, end stigma and ensure access to treatment of mental health and substance use across the state of Colorado.

Mental Health Colorado has a statewide network of advocates, called the Brain Wave. The Outreach Coordinator is responsible for the recruitment and orientation of Brain Wave members. She/he creatively communicates Mental Health Colorado's policy goals to Brain Wave members; identifies members to act as advocates on specific policy points; and connects members with other volunteer and advocacy opportunities.

ESSENTIAL JOB DUTIES

- Conducts on-boarding of new Brain Wave members to identify new members' experience and expertise areas related to mental health and substance use
- Matches skills/interest/experience of Brain Wave members with potential advocacy opportunities; strategically guides members towards ways to engage with opportunities related to their skills or interests
- Manages all communication to Brain Wave using email, phone, or face-to-face meetings
- Plan and facilitates monthly trainings/webinars for Brain Wave members and other trainings as needed
- Manages Brain Wave retention and engagement strategies, tracks progress towards short term and long-term goals
- Works to overcome barriers and challenges for Brain Wave representation from frontier and rural areas of Colorado outreach to communities outside of Denver metro area
- Organizes Brain Wave data for use in reports and grant applications. Tracks trends in engagement and growth, and identify any new data points to track
- Manages oversight of goals for Brain Wave; complies with grant requirements
- Maintains a broad knowledge of the landscape of mental health and substance use services in Colorado, stays updated on changes and how that may impact consumers
- Performs other duties as assigned
