

WEEKLY LEGISLATIVE UPDATE 1.13.20

The legislature returned to work on Wednesday, marking the beginning of another 120-day session. As of Friday (1/10/20) morning, the House introduced 82 bills and the Senate introduced 62 bills. Mental Health Colorado has flagged 29 bills so far that have a potential impact on individuals with a mental health or substance use condition, ranging from policies proposed by the Opioid and School Safety Interim Committees to expanding access to quality health care through Medicaid buy-in for aging adults.

Governor Polis delivered his State of the State address to the legislature on Thursday. He highlighted mental health with the following statement: "Reducing costs in our health care system will also help us tackle one of our most pressing problems—our state's mental health and addiction crisis." He emphasized the work of the Behavioral Health Task Force and the need for efficiencies in the system and appropriate step–down alternatives for individuals leaving inpatient settings. Other priorities that Governor Polis emphasized include paid family leave, universal access to quality pre–school, high prescription drug costs, tackling the high cost of health care, and clean energy.
