

LEGISLATIVE UPDATE

Politics at the Capitol

This week at the Capitol we began to see some cracks in the veneer of civility that had thus far covered both chambers. Debates dragged out a bit longer and final votes followed party lines a little more. The final deadline for the introduction of legislators' priority bills in the previous week meant that a slew of new legislation appeared this week, bringing the new total to 450 bills introduced. One of these, HB-1284, a Mental Health Colorado agenda bill, provides for a secure transportation alternative for individuals experiencing a behavioral health crisis. HB20-1139, Peer Support Professionals, another Mental Health Colorado agenda bill, passed its first committee hearing on Wednesday (2/5) in the House Public Health & Human Services Committee. The bill passed unanimously after over a

dozen witnesses testified in support (and none in opposition). It's now awaiting a hearing by the House Finance Committee before moving on to Appropriations.

Budget

The House tackled most of the departmental supplemental bills this week. These bills make mid-year adjustments to figures approved last spring through the regular budget process, allowing for more accuracy in some of the information impacting the budget such as caseload, student population, and cash funds revenues. There were 18 department supplemental bills and a handful of "orbital bills" in some way related to one or more of them. One in which Mental Health Colorado took particular interest was HB-1262, concerning appropriations for housing for people transitioning out of the criminal justice system. Unlike the other supplemental and orbital bills, which all received final passage on Thursday, HB-1262 was laid over until Monday to allow for further discussions due to concerns that the bill would negatively impact this program that

provides funding for housing for individuals with mental health and co-occurring conditions. With supplementals moving on to the Senate next week, the Joint Budget Committee has begun the early stages of their long figure-setting process, establishing figures that will ultimately appear in the FY '20-'21 budget, which will be introduced in March.

What's Coming

The House has a full calendar next week, both on the floor and in committees, suggesting there may be some long nights ahead. On Monday (2/10), the Energy & Environment Committee kicks off the week with

a few oil and gas bills, which always generate plenty of interest. Then, on Thursday (2/13), the House State Affairs Committee will hear seven highly controversial bills on LGTBQ rights. Over on the Senate side, the Senate Appropriations Committee will take up the supplemental and orbital bills on Tuesday (2/11) morning,

making it likely that floor debate on those would occur on Wednesday (2/12) or Thursday (2/13) in the full Senate.
